

#### E: EXCELLENT

TU aims to support environmental products and has a strong policy of supporting environment-friendly suppliers. All its plants comply with environmental and waste treatment standards. S: GOOD

Being reliant on seafood product and fishermen suppliers, TU has the highest exposure to this ESG pillar. However, it has managed its social and community relationships well. The company has a strong policy of not supporting labour malpractice suppliers. TU also applies international standards – as per those specified by Dow Jones Sustainability Indices and United Nations Sustainable Development Goals. It also conducts its social responsibility activities based on engaging in projects that are suitable for society needs.

#### **G: EXCELLENT**

TU follows the guidance of the Thai Institute of Directors. Its disclosure policy is in compliance with regulations set by the SET. As it is a listed company, TU also discloses important information broadly and promptly to stakeholders.

- 2Q23 results in line. TU posted a 2Q23 net profit of THB1bn (+0.7% QoQ, -37% YoY) in line with Street and our expectations. The group saw sales revenue rise 4% QoQ (-13% YoY) to THB34.1bn the QoQ increase was on selling price adjustments while the lower YoY was due to customers' high inventory levels vis-à-vis last year. GPM was at 16.9%, which was higher QoQ and flat YoY. TU booked better gross margin QoQ, mainly from selling price adjustments. Its THB1.9bn (+53%QoQ) operating profit was mainly due to lower freight and transportation costs. TU's restaurant chain, Red Lobster, posted lower losses YoY because of price increases, lower costs of goods sold, and a drop in labour costs from its turnaround strategy, but there were still QoQ losses due to seasonality. TU had extra losses, mainly from FX (c.THB250m). Finance costs were higher too following the elevated interest rate trend.
- Expect improved 2H23 demand but conservative gross margins. We expect TU to see better demand in 2H23 as it enters the high season in 3Q23. 3Q historically sees higher demand, mostly from Western Hemisphere markets, eg the US and EU, as this is the dining-out period there, given suitable weather for such activities. 2H23's orders should also increase food preparation, in our view, in anticipation for the 4Q23 festivities season. However, we are conservative on TU's fishing wing, given the hot weather that has brought about fishing difficulties. Hence, we trim GPMs to 16.3% from our original 17.4% estimate. The downside risks to our call: i) Volatility in raw material costs and ii) possible animal disease outbreaks/pandemics, which could adversely affect demand and supply.
- ESG. Given our increased weightage on the E pillar, TU's ESG score is 3.3 out of 4 vs our 3.2 country median. This results in a 2% ESG premium being added to its intrinsic value at a 1.3XP/BV target near its 5-year average to arrive at our THB17.50 TP. The stock's valuation remains inexpensive, as it is trading at 1x P/BV, ie below the 5-year average of c.1.3x. TU also provides attractive FY23F dividend yields of 4%. The group plans to pay dividends of THB0.30/share for 1H23. The XD date is set for 21 Aug with payment slated for 4 Sep. We maintain our BUY recommendation.


