Favourable 3Q22 Results In Line; Keep BUY


Company Update

Maintain BUY and DCF-derived THB18.70 TP, 32% upside and c.3% yield. Home Product Center's solid 3Q22 bottomline, YoY and QoQ, came mainly from strong sales, recurring income, and healthier GPM. We expect 4Q22F earnings to be its strongest quarter this year. Current valuation of below -1SD from its mean looks attractive.

Improving flight and passenger numbers should strongly support earnings – mainly via passenger service charges and concessions revenues.
