### Central Retail Corporation (CRC TB, BUY, TP: THB48)

Another Earnings Turnaround In 3Q22; Still BUY  
 Company Update

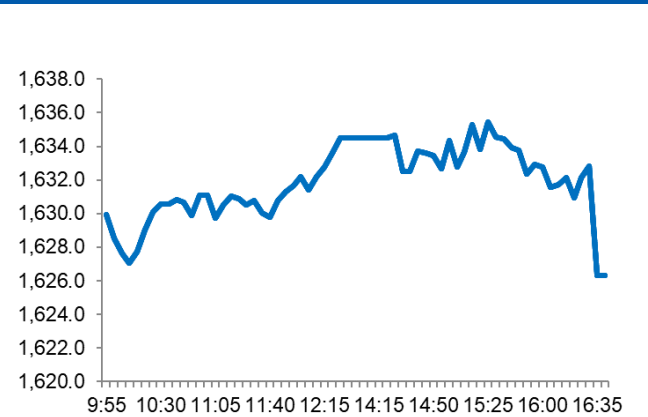
Still BUY, new THB48 TP (DCF) from THB46.50, 17% upside, 1% yield. We expect Central Retail Corp to post a strong 3Q22 core profit turnaround on positive SSSG across all key business pillars and a wider GPM. 4Q22 may be CRC's highest quarterly earnings this year, supported by new stores and a recovery in local consumption and international tourist arrivals. We think bottomline could achieve pre-pandemic levels in 2023.

<b>Airports of Thailand (AOT TB)</b>	82	10.07	<ul style="list-style-type: none"> <li>Expect smaller negative earnings YoY and QoQ in 4QFY22. Improving flight and passenger numbers should strongly support earnings – mainly via passenger service charges and concessions revenues. In addition, PTT is still working to capitalize on future business trends, such as in the EV-related space, and innovations in health and environmental products.</li> </ul>
