Berli Jucker (BJC TB, BUY, TP: THB41)

Robust YoY Growth In 3Q22; Keep BUY Results Review

Keep BUY and THB41 TP (DCF), 19% upside and 2% yield. 3Q22 net profit was below our forecasts by 10% due to an opex hike. Strong rental income recovery from the lockdown last year, moderate sales growth, and lower finance costs supported the vast profit growth YoY. We still believe 4Q22 may be 2022's strongest quarterly earnings for Berli Jucker. With our expected core profit growth of 37% and 29% for this year and 2023, BJC's 23x 2023F P/E (<-1SD) remains undemanding.

Osotspa (OSP TB, BUY, TP: THB31.50) Weaker-Than-Expected 3Q22 Numbers; Still BUY

Results Review

Still BUY, new THB31.50 TP from THB33, 18% upside and c.3% yield. Osotspa's 3Q22 net profit was below our and Street's forecasts, mainly due to cost hikes that undermined GPM and the opex-to-sales ratio. We retain the view that OSP's share price has reflected the bottomed out 3Q22 bottomline – it still deserves long-term investments, as the energy drink leader's premiumisation strategy may be accepted by 2023.

Improving flight and passenger numbers should strongly support earnings – mainly via passenger service charges and concessions revenues. Thai Union Group (TU TB)	24	37.93	<ul> <li>TU is progressing further in terms of debuting its pet food business on the stock market after it began the filing process with the SEC.
