- upcoming closure of two Big C hypermarkets this month, and re-location of a store in 4Q24 should not have a material impact (<0.5%) on its full-year earnings. We expect BJC's 2H24 core profit to improve from 1H24 on the back of better SSSG momentum in September, with the company to record its strongest quarter in 4Q. Its P/E valuation (-1SD) remains undemanding.


   Store closures and re-location. According to media reports. BJC's modern
- Store closures and re-location. According to media reports, BJC's modern retail supply chain (Big C Supercenter) has decided not to renew its lease agreements for two hypermarkets in Bangkok (Sukhaphiban 3 and Rangsit 2). The two stores will operate until 15 Sep and 30 Sep. Big C also announced that its Rat Burana hypermarket in Bangkok will remain open until 31 Oct 2024 before it moves to BJC's new freehold riverside location in 2025.
- No material impact. As of 2Q24, Big C contributed two-thirds of BJC's topline and 45% of net profit. It runs 158 hypermarkets nationwide. As the three impacted stores contributed c.0.7% of Big C's total full-year sales, we expect a limited impact of 0.1% and <0.5% to BJC's topline in FY24F and from FY25 onwards. We also see several factors to offset the impact: i) There are Big C hypermarkets in the catchment areas nearby the ceasing stores, which may attract customers and help offset the sales shortfall in the near term, and ii) Big C plans to launch one new hypermarket and renovate 18 existing stores this year, and add three more big box stores next year.
- SSSG. We expect Big C's developments in the high-margin fresh food and private label product categories to keep its overall SSSG flattish YoY in 3Q24 QTD (2Q24: -1.9%), with fresh food SSSG of c.7% YoY for the period. Sales momentum for September may be slightly better than the previous month. BJC's non-Big C businesses may benefit from new packaging customers, new consumer product launches, and fixed raw material and utility costs. We expect BJC to see higher 2H24 core profit than 1H. Earnings may rise YoY (but fall seasonally QoQ) in 3Q before its strongest quarter in 4Q.
- Maintain forecasts. BJC's core profit should see a modest 2% YoY drop to THB4.60bn in 2024 (2023: -5%) due to higher financial expenses. Still, its EBIT for the year should expand by 10% YoY. Key earnings drivers: i) Anticipated conservative 3% total sales growth and +1% SSSG for Big C, ii) 5% rise in other income on improving Big C leasable area operations, iii) higher GPM (+0.2ppts) and lower opex-to-sales ratio (-0.1ppts).
- Valuation. We applied a 4% ESG discount to BJC's intrinsic value to derive our unchanged DCF-based THB31 TP. BJC is trading at 21x FY24F P/E (-1SD from its 5-year mean).



## **Emissions And ESG**

#### Trend analysis

In 2022, BJC planted 9,140 trees, reduced Scope 1 and Scope 2 greenhouse gas (GHG) emissions intensity 4% and 5-10% YoY, increased the total renewable energy consumption by 10% YoY, lowered disposed waste by 30% YoY, lowered total weight of plastic packaging consumption by 2% YoY, and raised the usage of recyclable plastic packaging to 75% (2021:65%). In 2Q23, BJC carried out 10 environment-related activities, which helped to reduce CO2 emissions by 54 tonnes/year.

## **Latest ESG-Related Developments**

- In 2022, following BJC's 140 years of operations celebration, it established the 1 + 5 strategy a
  new BJC Sustainable Environmental Goals project beyond the industry norm, to be achieved
  before its 150-year anniversary. The project outlines BJC's strategy to reduce GHG emissions
  intensity from all its operations over the next 10 years. This enables BJC to contribute to the
  corporate-wide target to achieve net zero by 2050.
- The strategy comprises one build (to plant 150,000 more trees) and five curbs including to: i) Reduce Scope 1 & 2 emissions by 15% and 10%; ii) reduce 15% of non-renewable energy per revenue from the base year 2021; iii) reduce 15% of water consumption per revenue from the base year 2021; iv) reduce 15% of food waste per revenue from the base year 2021, and v) reduce 15% of packaging volume from the 2021 base year.
