Osotspa (OSPTB)

Valuation is still undemanding at around -2SD.

Domestic Business To Drive 2H24 Earnings; BUY

- Still BUY, new THB30.50 DCF TP (from THB30), 33% upside, c.4% yield. Osotspa's improving domestic market for beverage and personal care products is expected to drive its 2H24 performance, despite a low season for its international business (mainly in 3Q24). FY24 earnings are anticipated to surge by 24%, with 4Q24 earnings to see favourable YoY and QoQ growth.
- Domestic market. Management raised its FY24 topline growth guidance to a high single digit from mid-single digit previously. Its 2H24 outlook is driven by its Thailand operations, with strategies including: i) Strengthening its local energy drink (c.40% sales mix) portfolio by increasing its optimised onground marketing activities and tackling the premium segment, and ii) maintaining the sales momentum of functional beverages (c.18% mix) with new products. Its performance will also be driven by the personal care segment's (c.9% mix) high season in 2H24.
- Functional drinks. OSP is driving 2H24F functional beverage sales with the launch of a new vitamin C drink category "C-Vitt 1,000 mg", which is registered as a dietary supplement, but sold at the same price as its existing vitamin C drinks, given the lower excise tax rate. We believe OSP will be able to enhance its customer base with its expansion into the health supplements market, with room to improve the products' GPM.
- International markets. OSP is seeking opportunities to grow its beverage business in overseas markets. Its plans include: i) Re-entering the Vietnam market in 4Q24, ii) introducing new products in Laos to target new customer segments, and iii) securing a new distributor in Indonesia's Java region, and expanding in Sumatra and Sulawesi. While improvements in these markets may not be immediate, we expect OSP to see growth over the next few years.
- Outlook. OSP's 2H24 performance should improve YoY despite a softer sales momentum vs 1H24, due to the seasonal effect (low season) on its high-margin international business. 3Q24F core profit should grow YoY but fall QoQ on a low season for energy drinks in Thailand and Myanmar. There may be more one-off impairments from divesting non-core businesses, which undermine 3Q net profit. Stable production costs and a stronger outlook for its personal care business should help 4Q24 earnings grow YoY and QoQ.
- Forecasts. We raise OSP's core profit by another 4% for FY24F-26F to reflect improving sales and GPM. We assume GPM will rise by 1.9ppts this year to a record 36.4%. OSP should see strong YoY core earnings growth of 24% in FY24, and another 9% to THB3.34bn in FY25 (reaching FY19 levels).
- Valuation. Our TP includes a 0% ESG premium/discount. OSP is trading at an undemanding 22x FY24F P/E (c.-2SD from its 5-year mean). Strong FY24 core profit growth and a better 4Q24 performance are potential catalysts.




