Central Pattana (CPN TB)

Growth To Remain Healthy; Keep BUY

- Keep BUY and DCF-derived THB85 TP, 27% upside and c.2% yield. Central Pattana may generate a record THB3.43bn core profit (+38% YoY, + 6% QoQ) in 2Q23F, mainly driven by topline of all its businesses. Further support from malls, hotels, and residential operations to its latter half outlook may see 4Q23F as another good quarter and propel 2023F earnings to beat 2019 levels by 8%. Meanwhile, its valuation still looks undemanding.
- Solid topline in all businesses. We expect CPN's 2Q23 total revenue of THB10.62bn (+24% YoY, +6% QoQ) as all its businesses may deliver topline growth YoY and QoQ. Malls' customer traffic may improve to 91% of 2019 levels (2Q22: 85%, 1Q23: 88%) while rental rate discounts given to tenants returned to normal since 1Q23 (2Q22: c.14%). Its hotel business may still expand 83% YoY and 5% QoQ despite a low tourism season, thanks to its outperforming key properties ie Hilton Pattaya, which attained flattish revenue per available rooms QoQ and rising operations at its newly opened hotels. Residential revenue may generate impressive growth (+49% YoY, +48% QoQ) and boost its contribution to 9% (2Q22: 8%, 1Q23: 7%) due to major ownership transfers of two high-rise projects in Korat and Ayutthaya. We also assume equity profit of THB519m (+52% YoY, +9% QoQ) on its super-regional Mega Bangna mall's strong traffic beating the 2019 levels.
- 2Q23 preview. CPN may deliver THB3.43bn core profit (+38% YoY, +6% QoQ) this quarter. EBIT growth should be driven by sales and equity profit. Average GPM should be at 51.9%, up 3.3ppts YoY driven by the non-hotel business, but decline 0.5ppts QoQ due to a rising mix of residential revenue which provides lower profit margin than rental income. Opex-to-sales ratio may drop 0.9ppts YoY and 1.0ppt QoQ on a higher topline. 1H23 core profit may expand 39% YoY to THB6.67bn and account 53% of our 2023F's unchanged THB12.51bn core profit (+18% YoY and 8% above 2019 levels).
- 2H23 support ahead. We think CPN's further expansion one new mall (Central WestVille in late November), four new hotels, and six residential launches in 2H, as well as c.THB3bn transfer of two high-rise projects – should support its high 4Q23F to make it another good quarter. Electricity cost cuts from THB5.33/unit earlier this year to THB4.70 from May-Aug 2023, and likely decline further to THB4.45 from Sep 2023 may partially ease its 3Q-4Q23F opex. We still expect 2H23 earnings growth YoY, albeit, lower than 1H23 following the high performance base from retail malls' rapid recovery in 2H22. Planned consolidation of CPN Retail Growth Leasehold REIT's (CPNREIT TB, NR) financials may be finalised by 4Q23.
- Valuation. CPN's ESG score of 3.4 is two notches above the country median, so we apply a 4% premium to its intrinsic value to derive our TP, which remains at THB85 implying 30x P/E, or slightly above the 28x 5-year historical mean.




Recommendation Chart
