Still BUY and THB10.77 TP (SOP), 33% upside and >1% dividend yield. Bangkok Expressway and Metro should grow organically and consistently, in our view, from its three major businesses. This is especially so for the Blue Line Mass Rapid Transit (MRT) wing, which BEM guides will continue to mark a series of new high ridership records in

Organic Growth Still Plays a Vital Role; Still BUY


- After a busy month of commuting activities in Nov 2023, both expressway traffic and Blue Line MRT ridership numbers fell slightly (0.5% and 7% MoM) in Dec 2023 to reflect the long holidays prior to the New Year festive season.
- YoY growth intact in Dec 2023. For Dec 2023, both expressway traffic and MRT ridership numbers posted solid growth of 0.4% and 14.6% YoY. As usual, expressway traffic slowly crawled up to 1.13m trips/day. MRT ridership numbers grew faster (402k trips/day) as the resumption of meetings, incentives, conferences, and exhibitions or MICE activities supported the rising MRT ridership momentum. In addition, the Red Cross' annual fair (held at Lumpini Park on 8-18 Dec 2023) also helped boost ridership numbers within the Blue Line MRT's Lumpini Station.
- For FY23, the key distinction was both indicators catching up to normal seasonal patterns (similar to the pre-pandemic period) throughout the year. The major differences between these two indicators: MRT ridership consistently broke new record highs while expressway traffic numbers' gradual improvement was not able to reach pre-COVID-19 levels. Hence, actual expressway traffic numbers grew 7.4% YoY to 1.12m trips/day while MRT ridership levels jumped 44% YoY to 390k trips/day.
- Fine-tuning our forecasts. In order to reflect both FY23's actual numbers, we revised our FY23 core revenue by 6% to THB16.5bn (+17% YoY) this resulted in our new FY23F earnings of THB3.4bn (+40% YoY). Although we revised down our FY23F bottomline, a strong earnings growth in FY23 should be derived from: i) Higher commuting activities leading to rising expressway and MRT numbers, ii) solid GPM of >60% from the expressway and commercial development businesses throughout the year, and iii) the MRT wing's FY23 GPM turning from FY22's negative figures.
- As usual, 4Q23 earnings will rely solely on operations from three core businesses without major support from dividend income. Post our revision, we expect a 4Q23 net profit of THB805m (+33% YoY, -17% QoQ).
- Maintain TP. Based on the solid organic growth of BEM's core businesses, we make no change to our SOP-based THB10.77 TP. Our TP includes a 2% ESG premium based on the company's ESG score of 3.3 vs the country's median of 3.2.


Figure 1: 4Q23 earnings to be driven YoY by stronger businesses especially MRT business

Emissions And ESG

Trend analysis

 Data in the table is the sum of BEM's Scope 1 and 2 emissions, and contains only greenhouse gas emissions from its MRT business.

Rail systems

- In 2022, the fuel use rate related to Scope 1 emissions of the rail systems – with respect to common vehicles – decreased 9.6% YoY.
- In 2022, the rail systems' electricity use rate with regards to Scope 2 emissions – increased by 1.33% YoY, as the volume of electricity used in 2021 was lower than usual. This was in tandem with the reduced service hours in accordance with government measures imposed to prevent the spread of COVID-19 infections.

Expressway systems

- In 2022, the rate of fuel used in running the expressway systems (ie Scope 1 emissions) – with respect to operating vehicles – decreased by 7.2% YoY, and that for common vehicles decreased by 16.5% YoY.
- In 2022, the expressway systems' electricity use rate

 related to Scope 2 emissions decreased by 32% from levels recorded in 2014-2017.


