Regional Oil & Gas

The Situation Is Dire For April-May

- Top Picks: PTT Exploration & Production, Dialog, and Keppel. Demand has collapsed by >20mbpd while producers continue to produce as normal. We estimate landed global storage has c.20-45 days before being full. Crude oil prices indicate the need to cut production now: OPEC+ could cut production before May. Unless the global lockdown remains, 2H20 should improve, given demand recovery, the 7.7mbpd production restrained by OPEC+, and global inventory starting to draw down. Our 2020F-2021F crude oil prices are maintained: USD40.00 and USD55.00/bbl.
- The basics of crude oil is that it can either be kept underground as reserves, go to refineries for consumption, or placed in storage on land or seaborne facilities. Refiners will procure only to meet demand if there is no demand, production will be cut. Crude oil then goes into storage facilities. If such facilities are full, then it has to stay in the ground as reserves. What the market does with the crude oil at each part of the value chain will dictate the direction of crude oil prices, in our view.
- With >40% of global population under lockdown due to the COVID-19 pandemic during April-May, demand destruction is estimated at 20-30mbpd during this period. With refiners cutting runs and producers continuing to produce at normal levels, global storage facilities are filling up fast.
- The world's available storage capacity remains highly uncertain, with a wide range of estimates by various agencies. Global commercial onshore crude oil storage is at an estimated c.3bnbbls, while global spare capacity is at c.400-900mbbls currently. Assuming there is a global oversupply of 20mbpd, then it will take 20-45 days before global capacity is full.
- Apart from the landed storage facilities, there are c.750 supertankers globally with capacities of 2mbbl each that is another estimated 1,500mbbls of possible storage capacity. There are currently 80 supertankers now being used to store oil: c.147-160mbbls of oil storage at sea.
- The current attention remains firmly on the US producers and storage facilities. Although there are 130mbbls of onshore storage facilities, more than half of this is located on the Gulf Coast. Due to logistical issues, it is not be easy to fill these storage facilities. The collapse of the NYMEX May WTI crude futures contract on Monday indicates that storage capacities are running out, and this will most likely put further pressure on the WTI. We expect US shale oil to curtail production by c.1-3mbpd by 4Q20.
- Saudi Arabia is now facing a situation where there are no buyers, as
 there is no storage regardless of what level of output it sets, according
 to the Wall Street Journal. At least four tankers that left Saudi Arabia in
 March have been idling off the coasts of Egypt, Singapore, and Malaysia
 with no final destinations. As such, the kingdom may cut crude output as
 soon as possible, expressing the willingness "to take any additional
 measures in partnership with OPEC+".
