# **OPEC+ Deal: Uncertainty Ensures**

- Top Picks: PTT Exploration & Production, Dialog, and Keppel. Markets had already priced in a 10mbpd cut and were expecting more. This announcement will be disappointing for them. The OPEC+ deal may not balance the oil markets outright, but should support crude oil prices at ±USD30.00-plus/bbl until demand returns. Hence, it still allows natural rebalancing to occur. Latest news: Mexico rejected the OPEC+ deal, while Saudi Arabia indicates "no deal" if Mexico rejects - uncertainty ensues.
- OPEC+ has announced unprecedented cuts of 10mbpd for May-June, 8mpbd for July-December, and 6mbpd for Jan 2021, according to S&P Global Platts. Some sources, however, are indicating that 6mbpd cuts will be from Jan 2021 to Apr 2022. The current deal is better than what we expected, as its production cuts timeframe is much longer.
- There has been no announcement on how the production will be divided up amongst the OPEC+ members, or the baseline from which the production cuts will be determined at the moment. This is important, as Saudi Arabia produced 9.6mbpd as of March and will be producing 12mbpd as of April. It has been reported that Saudi Arabia and Russia will lower production to c.8.5mbpd or 8.75mbpd. Normally, production cuts are determined from production rates two months prior to an agreement.
- · This amount may seem not enough to balance the oil markets, given that the International Energy Agency expects global oil demand destruction at 20mbpd. However, OPEC sees 2Q20 global oil demand destruction at 12mbpd and expanding. For 2020, OPEC sees oil demand contracting by 6.8mbpd, similar to our worst-case scenario.
- OPEC+ will now seek to widen the agreement with other G20 nations, including the US, Canada, and Brazil, as well as non-G20 member Norway. However, we believe the offer will come in the form of economically driven shut-ins as part of their contributions. The meeting will be held today.
- What this deal does. Although the deal will not balance the oil markets outright, it should support crude oil price at the ±USD30.00-plus/bbl range until demand returns. At this price range, natural rebalancing will still occur, as a majority of higher-cost producers will still have to curtail production. This deal should also lower the amount of oversupply and strain in global storage.
- We maintain our 2Q20-4Q20 crude oil prices for the moment at USD25.00, USD37.00, and USD45.00/bbl, and USD40.00/bbl for FY20. For our base case, we expect natural rebalancing to occur in 4Q20. However, the OPEC++ intervention will move up this timeline. We await the final outcome from today's OPEC++ meeting. We have not yet seen any official announcement from OPEC - the details above are from media reports. The latest news: Mexico is reportedly refusing to go along with the current OPEC+ deal. Saudi Arabia indicates no deal if Mexico rejects.
