Company Update

Maintain BUY, TP of THB51.00, 24% upside, c.2% FY20F yield. At PTT Global Chemical's analyst meeting yesterday, management said strategy and investments remain in place, but it will look at cutting opex and improving efficiency. As its plants are flexible, it will be looking to capture products that are in high demand (healthcare/single-use plastics), while deprioritising products with less demand (jet fuel and gasoline). It will also continue to look at the US petrochemical investment and other M&A opportunities.

**Thai Oil (TOP TB, BUY, TP: TH54.00)**

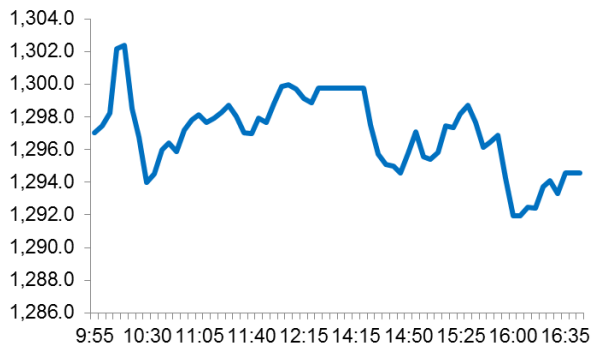
On Track For a Recovery  
Company Update

Maintain BUY and THB54.00 TP, 23% upside and 3% yield. At an analyst meeting today, Thai Oil highlighted the impact of COVID-19 on its operations and action plans moving forward for this challenging year. The company expects GRM to recover as a result of a lower official selling price crude discount in 2Q20, while 2H20 should see oil demand recover. TOP's refinery expansion project remains on track for commercial operation date in 1Q23.
