Company Update

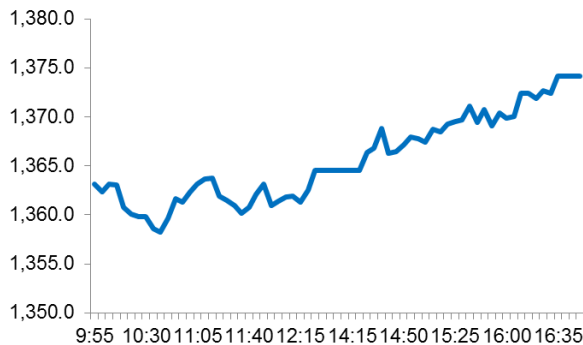
