Company Update

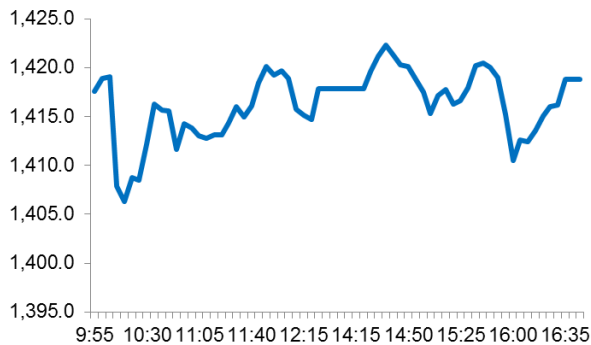

The strong catalyst ahead: Success in winning the Orange-Line MRT concession, as we believe the BEM-led consortium will be the likely bid winner.
