Challenging Quarters Ahead

Company Update

NEUTRAL, new TP of THB21.30 from THB14.50, 0.5% downside with c.1% FY20F yield. We roll over our valuation to 0.5x FY21 P/BV. We caught up with Bangchak's management last week. After getting an update, we cut our GRM estimate, and decrease our crude run forecast to 100kbpd for the year. The retail business remains challenging, as demand for transportation fuel continues to fall. However, its power plants should continue to provide stable earnings.

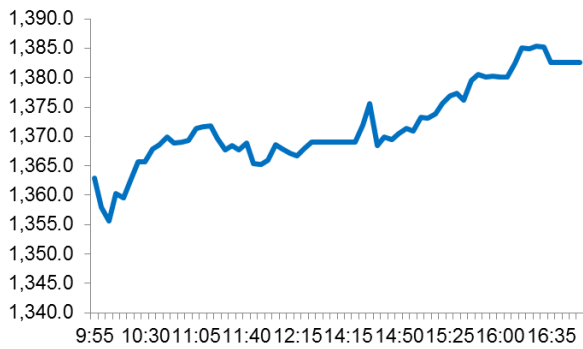

- Global confirmed cases surpass the 7m mark
- Number of cases in the US surpassed 2m and sparked fears of a potential second wave of infections
