Company Update

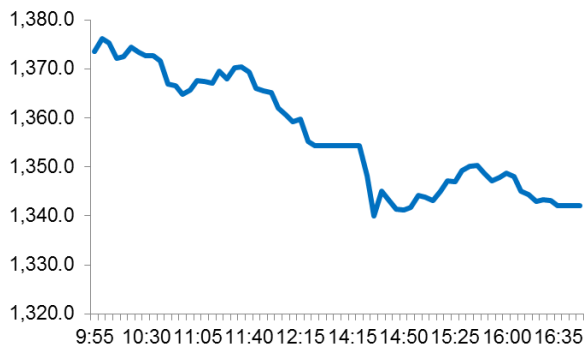
