Sector Update

Now NEUTRAL on the sector. Outpatient traffic has risen only marginally, as fear of infection has decreased and lockdown measures have been relaxed. That said, we expect revenue intensity of premium healthcare operators to decline, as they shift focus to competitive pricing to maintain the utilisation rate since the medical tourism slowdown. We remain upbeat on the small-cap hospitals which should benefit from an improved Social Security Office payment scheme, but sector valuations are stretched
