Still UNDERWEIGHT. NokScoot Airlines' cessation is another case of COVID-19 impact's on tourism-related sectors. Yet, we see limited impact to Airports of Thailand (AOT) due to its minimal contributions to total aircraft movement. We also believe government plans to allow foreigner visits with quarantines as not attractive, providing no material upsides to hoteliers and AOT. The outlook for foreign visitors, the key source market, remains dull
