
2Q20F Net Profit Set To Plunge 31% QoQ

Results Preview

Maintain BUY and THB108.00 TP, 13% upside and c.3% yield. 2Q20 net profit is expected to plunge 31% QoQ to THB5.9bn, on lower sales volumes and softer selling prices. However, we do expect a pick-up in PTT Exploration & Production's 2H20 sales volumes from 2Q20's lows, while 4Q20 should see the Sabah-H natural gas project enter (+20kboepd to 4Q20F volume). We expect crude oil prices to average at USD45.00/bbl (Brent) in 2H20, as OPEC+ continues to monitor and balance the oil market Analyst: Kannika Siamwalla CFA +66 2088 9744


