Defensive With Attractive Valuations; Keep BUY


Company Update

Maintain BUY and THB17.50 TP, 30% upside with c.2% yield. While the COVID-19 resurgence may put pressure on a medical tourism recovery and Bangkok Chain Hospital's pre-opening projects near Thailand's borders, its outlook should remain solid – supported by pandemic-related services and the government healthcare scheme segment. The current valuation is still attractive, at a relative discount vis-à-vis its peers.
