Finding Opportunity In Crisis; Keep BUY

Company Update

Keep BUY and THB49.00 TP, 38% upside and 2-3% yields. Osotspa may continue to deliver robust double-digit earnings growth in 2021, mainly driven by functional beverages, its Myanmar operations, more new product launches, and the ongoing success of its cost-savings programme. Amid the COVID-19 resurgence, strong vitamin C drink sales may limit the impact to 1Q's outlook, with possible normalising high season for beverages in 2Q.
