Still SELL with new DCF-based THB28.50 TP from THB29.00, 16% downside and slightly >1% yield. This market share leader is expected to deliver slow earnings growth in the forthcoming year after missing FY20 growth opportunities. Although there will be a new business model executed soon, a tougher local market situation should mitigate any of TOA Paint's new growth attempts.

Economic Research

Deflation To End In 1Q21

Economics View

- We expect the Consumer Price Index (CPI) to edge up to +0.2% YoY in 1Q21 from -0.4% in 4Q20. It would then see a jump to 1.6% YoY during 2Q21, but the spike is likely to be an inflationary mirage amidst the low base effect in 2Q20.
- We think the Bank of Thailand (BoT) will keep the policy interest rate unchanged at 0.5% despite rising inflation in 2021. The BoT will be focused on growth rather than inflation.
- December CPI printed -0.3% YoY vs the Bloomberg consensus estimate of -0.4% and November reading of -0.4%.
