Too Attractive To Ignore; Keep BUY

Results Review

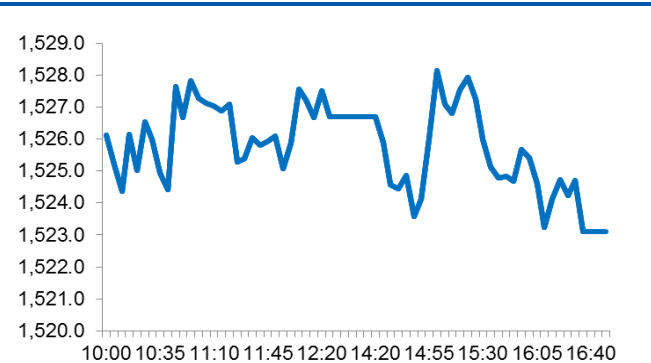
Keep BUY and THB68.00 TP, 30% upside, c.5% yield. FY20 results were in line with our expectation, but beat Street's. We believe earnings will gradually hit a record high in FY21-22, with strong upsides from potential projects. Opportunities to acquire new capacities – following US President Joe Biden's green plans – should be another catalyst to drive share price momentum. At current P/E, valuations are undemanding with compelling risk/reward. Yields are higher too vis-à-vis peers' c.2.5% average.
