Company Update

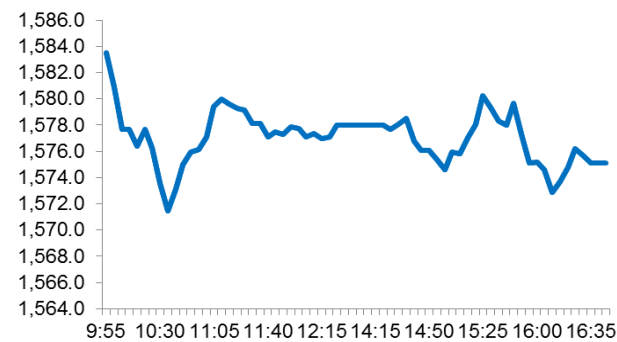
