Central Plaza Hotel (CENTEL TB, SELL, TP: THB29.00)

Another Small, Yet Spicy Deal; Keep SELL Company Update

Still SELL, with a FY21F DCF-based THB29.00 TP, 21% downside. Central Plaza Hotel's latest acquisition – the 6-outlet Somtam Nua restaurant chain – may be small and without material upsides to this year's earnings, but we expect further growth in the longer term from the opening of new stores and utilising the brand within the Cloud Kitchen platform. We continue to believe CENTEL's hotel wing may remain a drag on FY21 earnings, while the share price has rallied on sentiment over Thailand's planned tourism re-opening models. Economics View

- We expect the Manufacturing Production Index (MPI) will turn positive on a %YoY basis next month, supported by a low base effect and the recovery in global demand.
- The Feb 2021 MPI printed -1.08% YoY vs the Bloomberg consensus estimate of 0.1% and January reading of -2.0%.
- We expect a weak recovery this year amidst the lingering impact of the pandemic. The central bank will keep its policy interest rate at a record low of 0.5% for 2021 to support the recovery.


