Power Ratch (RATCH TB)	At The Energy Policy and Planning Office's (EPPO) board meeting on 1 Apr, guidelines for promoting competition in the natural gas business Phase 2 in Thailand were approved.	We believe this development will generate positive sentiment for the aforementioned power producers, given approvals by the authorities. Initially, we are of the view that the ones that will benefit the most – in order of highest to lowest – should be BGRIM, GPSC, EGCO, GULF, and RATCH. This is because of their high exposure to revenue from industrial users (IUs).	Sector: OVERWEIGHT
Electricity Generating (EGCO TB)	The guidelines divided gas suppliers into two groups: i. Regulated market: This grouping is operated by PTT (PTT TB, BUY, TP: THB51.00). There are three sources of gas supply that comes from “old supply”, ie the Erawan and Bongkot gas fields, Myanmar's gas fields, and the importing of 5.2m ton pa of LNG. In the meantime, “old demand” includes gas users such as PTT's subsidiaries, Electricity Generating Authority of Thailand (EGAT), and Hin Kong Power – a 51:49 JV between Ratch (RATCH TB, BUY, TP: THB68.00) and Gulf Energy Development (GULF TB, NR). We note that these users will not benefit from the low average pool gas price due to the pass-through cost mechanism in their agreements with PTT;	We note that the IU portion is not affected by a pass-through mechanism. We also want to highlight that, the lower the imported LNG prices, the higher the margins for a power plant's operations. Moreover, the aforementioned firms may have opportunities to undertake LNG trading with IUs in industrial areas within Thailand.	Stocks: RATCH: BUY, TP: THB68.00
Global Power Synergy (GPSC TB)	ii. Partially regulated market: The gas supply of this grouping comes only from imported LNG. The LNG shippers currently are GULF (300k tons pa), B Grimm Power (BGRIM TB, NR) (650k tons pa), Electricity Generating (EGCO TB, BUY, TP: THB230) (250 tons pa), and Global Power Synergy (GPSC) (TBA). EPPO expects the new shippers to be allowed to import LNG in 3Q21 at the earliest. It said these shippers will be allowed to use LNG terminals and gas transmission pipelines after PTT's related properties are clearly divided.
