Strong Rebound Prospects; Stay BUY

Company Update

Maintain BUY, new SOP-based TP of THB10.40 from THB11.50, 29% upside with <2% FY21F dividend yield. Expressway traffic has continued to recover, and ridership on the MRT Blue Line still improved as each wave of COVID-19 infections in Thailand is brought under control. As such, we expect its numbers to continue rising when the third wave of infections is tamed. Bangkok Expressway and Metro's earnings should grow moderately YoY in FY21, before strengthening further in FY22.

Malls, Retail Stores Shut By 9pm

Sector News Flash

Still NEUTRAL; Top Picks: CP All and Home Product Center. We expect slight effects from the earlier closure of retail stores and shopping malls at 9pm from 15 Apr onwards, but the escalating third spread of COVID-19 may undermine the retailing sector's short-term outlook. Despite this, retailers may still be able to deliver YoY 2Q21 and FY21 earnings growth from a low performance base. Negative sector sentiment may be an opportunity to accumulate retailers' stocks.


