

Central Pattana's asset spin-off may limit 1Q21's YoY earnings decline and, while the third COVID-19 wave may cause another hiccup in 2Q (now the weakest quarter), profit may still be able to grow YoY. Operational recoveries and new malls may strengthen the latter half outlook vs 1H21.
