Company Update

BUY, higher DCF-based THB500.00 TP from THB440.00, 11% upside and c.3% yield. Siam Cement has performed well in all its core businesses on a YTD basis, led by the petrochemicals division and its subsidiary's packaging business. Following its excellent 1Q21 earnings, we expect the positive momentum to continue in the subsequent quarters.

Higher Sales Volume Guidance; Keep BUY

Results Review

Keep BUY, with new THB131.00 TP from THB126.00, 13% upside and 3% yield. 1Q21 net profit improved 64% QoQ to THB8.7bn on stronger ASP (+10%) and lower unit costs amidst flattish sales volume. 2021 sales volume guidance is lifted to 405kboepd (+14% YoY), while natural gas prices are expected to fall by 11% to USD5.6/mmbtu in 2021. Near-term earnings impact to the Mozambique LNG Project force majeure is minimal, but could delay its expected first cargo delivery in 2024, if the situation prolongs.

Manufacturing Recovery Will Continue Into 2Q21

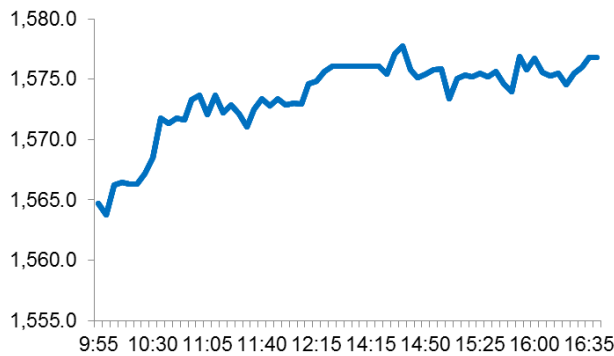
Economics View

- We expect the manufacturing production index (MPI) recovery will continue into 2Q21, supported by the low base effect and the strong external demand.
- The March 2021 MPI printed 4.12% YoY versus the Bloomberg consensus estimate of -0.4% and the revised February reading of -1.35%.
- Despite the anticipated recovery ahead, we expect Bank of Thailand will keep its policy interest rate at a record low of 0.5% as the Kingdom faced with a third wave of COVID-19 infections.

Local aviation sees favourable recovery: its domestic recovery may approach pre-pandemic levels by FY23, a year ahead of the international side. The Government's latest approval for Phase 3 of the "We Travel Together" local tourism stimulus campaign, from May to August, may be a catalyst and boost flight numbers. The improvement in cement & building materials business should be noticeable in 1Q21, with cement demand growing 1-2% in Thailand. This would be due to stronger demand from the residential property sector in provincial areas, and continuously solid demand stemming from government infrastructure projects. FY21 will start out with strong earnings growth in 1Q21, while the petrochemical division may be driven by higher production volume after de-bottlenecking the Map Ta Phut olefin cracker finishing 2Q21. For 2H21, we expect a brighter outlook for the cement & building materials business especially in ASEAN countries, when construction activities resume to normal.
