Export Growth Will Moderate In 3Q21

Economics View

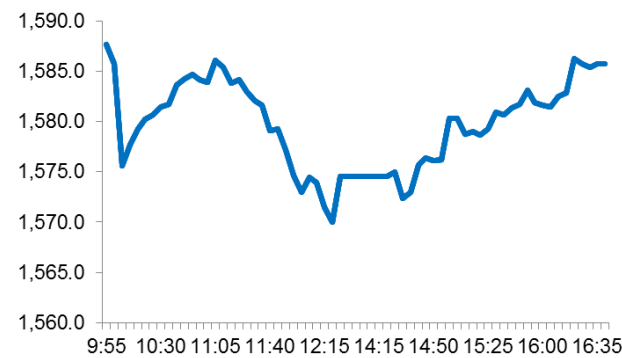
- We expect the strong export growth to moderate in 3Q21, as the low base effect diminishes while the electronics and automotive sectors will experience production disruptions amidst the semiconductor shortages.
- May exports printed 41.59% YoY vs the Bloomberg consensus estimate of 33.5% and April's growth of 13.09%. The stronger-than-estimated growth was led by the global economic recovery and all key products categories seeing a faster pace of growth – with the exception of gold.
- Imports recorded 63.54% YoY growth in May vs the Bloomberg consensus estimate of 53.65% and April's print of 29.79%. The strong imports were led by surge in oil-related products, raw materials, and capital goods.

Central Pattana (CPN TB)	<p>Local capital market news media Kaohoon recently revealed – citing an informed source – that Central Pattana was looking to acquire shares in Siam Future Development (SF TB, NR), a listed retail developer that focuses on community malls and small-scale shopping centres.</p> <p>The report claims that CPN might kick off the deal in July by purchasing 29.58% of SF's outstanding shares from the latter's major shareholder, Major Cineplex Group (MAJOR TB, NR). <i>(Kaohoon)</i></p>	<p>At this point in time, there has been no confirmation from CPN with regards to this deal. However, acquisitions remain one of its investment opportunities in terms of expanding its business and enhancing longer-term earnings growth. Based on CPN's 1Q21 balance sheet, the company's 0.45x net D/E ratio is still far below its debt covenant of 1.75x, implying that it may have room for investments through debt financing of up to c.TH90bn.</p> <p>SF operates 18 commercial development projects in the Greater Bangkok area, with a large-scale landbank in northern Bangkok for future project development. The firm's earnings have been resilient over the past three years, mainly driven by the share of equity profits for a 49% investment in its flagship large-scale Mega Bang Na mall. The latter is located in the strategic eastern Bangkok area. In 2020, SF's core profit stood at THB1.6bn (-28%) vs CPN's THB7.3bn (-38%).</p> <p>If this deal were to happen, we think it may strengthen CPN's competitiveness and drive short-term earnings by adding smaller retail projects and the large-scale Mega Bang Na mall into its portfolio. Potential asset spin-offs are also likely. However, we are of the view that this news needs further reaffirmation from other sources. We will closely monitor the news flow to see what develops. For now, we maintain our call and TP on CPN.</p>	BUY, TP: THB61.00

Expect full-year earnings returning to pre-pandemic levels in 2021. • To finance the acquisition of Tesco Lotus with a combination of debt and perpetual debentures to balance its leverage.
Home Product Center (HMPRO TB)	17.00	14.86	<ul style="list-style-type: none"> • Expecting normalising earnings in FY21 – to be supported by full-year operations of all stores and retail malls vs a temporary closure from late March to mid-May, with profit margins approaching pre-pandemic levels. • HMPRO's investment in Vietnam may strongly benefit growing urbanisation and a potential rise in the construction sector. • Quarterly earnings momentum will continue its upward trajectory in 1Q21. • Rapid improvement in sustainability development may allow the stock to continue trading at a premium.

Public investment via Gov.'s disbursement scheme should help to drawdown loans from KTB. FY21F earnings is set to rebound like other banks, mainly on lower set of provisions, improved fee incomes, while its NII is likely to maintain following a gradual rise in loan offsetting lower NIM. The valuation is compelling with current P/BV at 0.4x.
Muangthai Capital (MTC TB)	73.00	27.51	<ul style="list-style-type: none"> One of the leaders in microfinance market which provides a variety of loan products. Ample opportunities to grow through the ocean of untapped customers who cannot reach credits from traditional banks. HDPE-naphtha spread in 1Q21 should remain as high as levels recorded in 4Q20, while the polypropylene-naphtha spread reached another high in 1Q21. SCC's polyolefin sales volumes returned to normal levels after the turnaround of the Map Ta Phut olefin cracker was completed in 4Q20. The improvement in cement & building materials business should be noticeable in 1Q21, with cement demand growing 1-2% in Thailand. This would be due to stronger demand from the residential property sector in provincial areas, and continuously solid demand stemming from government infrastructure projects. FY21 will start out with strong earnings growth in 1Q21, while the petrochemical division may be driven by higher production volume after de-bottlenecking the Map Ta Phut olefin cracker finishing 2Q21. For 2H21, we expect a brighter outlook for the cement & building materials business especially in ASEAN countries, when construction activities resume to normal.
