### Global Power Synergy (GPSC TB, BUY, TP: THB88.00)

Right Time, Right Directions

Company Update

BUY, new THB88.00 TP from THB82.00, 12% upside with 2% FY21F yield. Global Power Synergy's 2Q21 earnings beat our forecast due to a surprise insurance claim and the stronger-than-expected performance from Xayaburi Power Plant. We like its strategic direction in: i) Its recent asset acquisitions and ii) the debut of its first battery factory. We believe investors will realise its growth path better and add further value to its businesses. We also imputed the two new assets into our forecasts. GPSC is also expected to book record high earnings over a sustained period.
