### Berli Jucker (BJC TB, NEUTRAL, TP: THB37.00) – DOWNGRADE

Outlook Still Attractive; D/G To NEUTRAL

#### Company Update

Downgrade to NEUTRAL from Buy, new DCF-based THB37.00 TP from THB44.00, 3% upside with c.1-2% yields. Berli Jucker's FY21F earnings may fall by 22% YoY and hit a bottom in 3Q21F, due to sluggish rental income and despite SSSG improving. However, its numbers may rebound gradually from 4Q21F onwards, amid rising manufacturing cost pressures and competition in retail. Catalyst: Easing COVID-19-related restrictions.
