Another Hurdle In 3Q21; Maintain SELL

Company Update

Keep SELL and DCF-based THB32.50 TP, 2.4% downside, c.2% dividend yield. After fairly good earnings in 1H21, we expect TOA Paint to enter its toughest quarter in 3Q21, with the domestic market and its ASEAN operations both facing a slowdown in sales revenue since July.
