Company Update

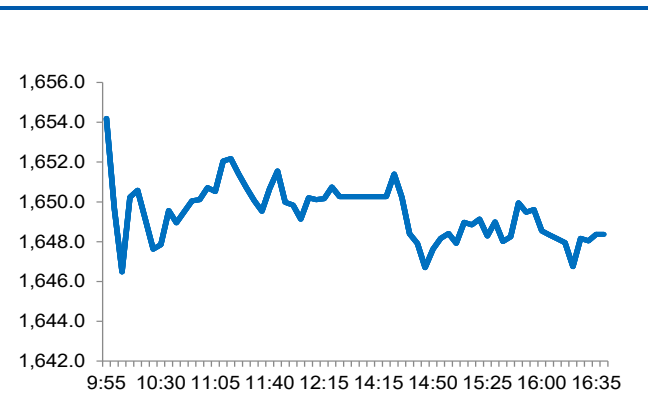
Maintain SELL, with new DCF-based TP of THB2.45 from THB2.15, 17% downside. Although we raise our earnings forecasts and TP from the double-digit growth in 1H21, we believe Dynasty Ceramic's earnings peaked in FY21 – 2H21 is expected to be a challenging period, especially in terms of boosting sales volume.
