Here Comes Consumption Recovery; BUY

Company Update

Keep BUY and THB132.00 TP, 17% upside, c.4% FY21F yield. We expect PTT Exploration & Production to benefit from solid oil prices, owing to lower crude oil inventory levels – as oil consumption has improved, due to the global economic recovery. Sales volumes are expected to surge to 412 kboepd (+16% YoY), and 485-490 kboepd in 2022 – supported by the G1/61 and G2/62 projects and full-year contributions from Sabah H and Oman Block 61. Demand for oil should recover as vaccination rates increase. We still favour this stock, as PTTEP is seeing robust growth.

GE Phase 5 Undergoes Unplanned Shutdown; BUY

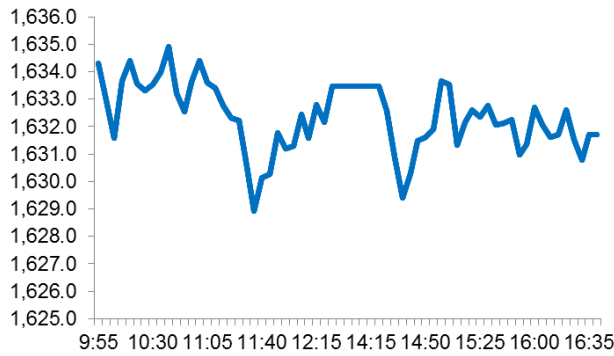
Corporate News Flash

Maintain BUY and THB88.00 TP, 13% upside with c.2% FY21F yield. Global Power Synergy's GLOW Energy (GE) Phase 5 is, once again, undergoing an unplanned shutdown, but is expected to resume operating in early 2022. We are slightly downbeat on this, as the shutdown will dim investor sentiment and tone down our FY21 outlook. That said, investors should look towards its growth prospects in power and energy storage, rather than on a short-term disruption. We recommend investors to enter into buying positions at THB75.00-80.00 per share.
