PTT Exploration & Production (PTTEP TB, BUY, TP: THB138.00)

Riding On Robust Oil Prices; Reiterate BUY

Company Update

BUY, new THB138.00 TP from THB132.00, 17% upside with c.4% FY21F yield. We expect PTT Exploration & Production to benefit from robust oil prices, on the basis of lower crude inventory levels – as consumption has improved. As such, we lift our oil price assumptions to USD71.00-69.00/bbl for 2021-2022. Sales volumes are expected to surge to 412kboepd (+16% YoY) this year, and 485kboepd (+18%YoY) in 2022 – supported by the Bongkot and Erawan fields, and the Sabah H and Oman Block 61 projects. We still like this stock, due to the company's solid growth prospects.
