Company Update

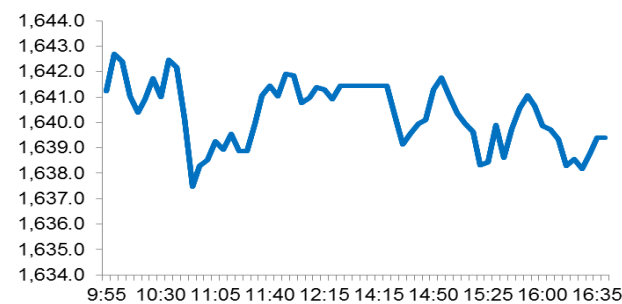
BUY, higher THB517.00 TP from THB500.00, 27% upside and 4% yield. Weaker 2H21 HoH earnings prospects are estimated, but solid 1H21 net profits were secure enough for strong FY21 earnings growth. We think the next petrochemicals up-cycle will be in late FY22 (earliest), and cement & building materials and packaging products demand will improve accordingly – as soon as post-lockdown nationwide economic activities resume. At 11x FY22F P/E, the share price is undemanding.
