Kiatnakin Phatra Financial Group (KKP TB, NEUTRAL, TP: THB61.00)

3Q21: Beat On Lower ECL, Topline Muted

Results Review

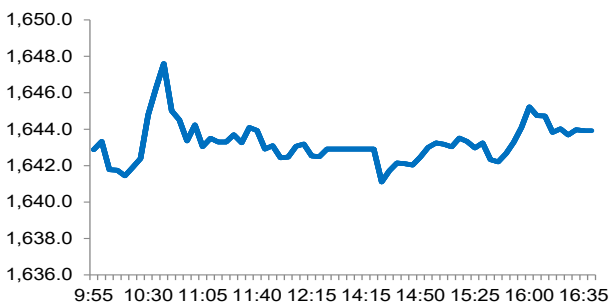
Stay NEUTRAL, new THB61.00 TP from THB56.00, 6% upside. 3Q21 results beat our and Street's expectations on lower-than-expected provisions. We had initially expected a softer 3Q21 before a rebound in non-II and modest growth in hire purchase (HP) loans lifts 4Q21 earnings. We believe its capital market business will remain strong in 4Q21. Given Kiatnakin Phatra Financial Group's better-than-expected performance, and signs of recovery, we see upside risks to our forecasts. Post-results analysts meeting is scheduled for 21 Oct.
