Stay BUY, new THB165.00 TP from THB150.00, 16% upside with c.3% yield. 3Q21 earnings beat our estimates on lower-than-expected opex. We believe Kasikornbank is ready for the new digital era, as it has business units that are fully equipped with new tech. We think this will be hidden value waiting to be unlocked in future. Historical price trends suggest KBANK's share price should outperform peers when the economy is on a recovery path. As it offers compelling valuations, it is our preferred bank stock. 
