 Company Update

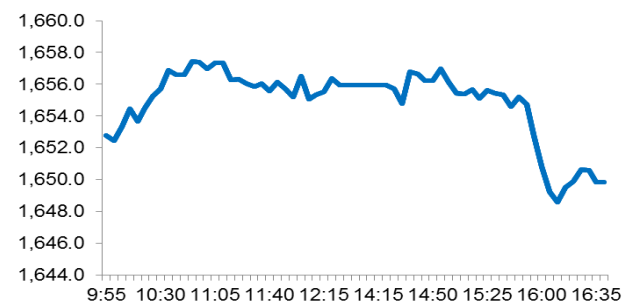

For 2022, the group is expected to book solid numbers from its exploration, refinery and trading arms, after weathering through a tough 2021. We also believe the global economic recovery will boost the demand for oil & gas.
