Going Past the Inflection Point; U/G To NEUTRAL


Company Update

Upgrade to NEUTRAL from Sell, new DCF-based TP of THB2.80 from THB2.45, 2% downside with c.6% FY22F yield. Dynasty Ceramic passed the low cycle of domestic demand for ceramic tile products in 3Q21. As such, we lift our earnings forecasts to reflect the anticipated pick-up in business ahead.
