Company Update

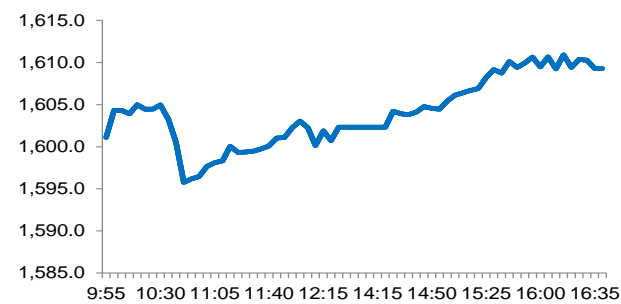
BUY, new THB76.00 TP from THB73.00, 30% upside, c.6% yield. PTT Global Chemical should benefit from higher gross refinery margins (GRM) in 4Q21 and FY22, in tandem with stronger oil demand from the economic recovery. PTTGC is looking to increase its exposure to high-value products, while Omicron fears appear to be easing, given the less severe symptoms seen among those infected.
