Company Update

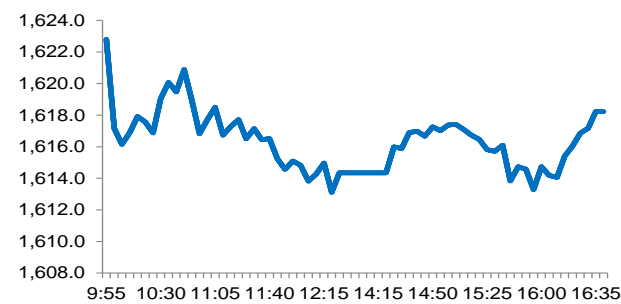

As soon as the pandemic situation is less severe, we think BEM's businesses will gain stronger momentum.
