HANA Microelectronics is an electronics manufacturer service provider focusing on printed circuit board assemblies and integrated circuits, which are high in demand. HANA is currently expanding, with NPAT expected to grow 36% and 26% in FY21F-22F. Its power management business in South Korea, which designs and manufactures its own silicon devices using silicon carbide, will likely be a catalyst.

Company Update

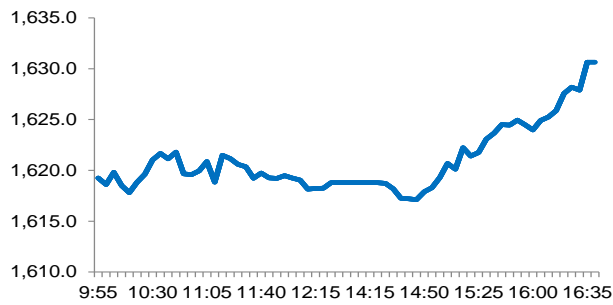
