Company Update


U/G to BUY from Neutral, new THB11.70 from THB7.30, 21% upside and c.2% yield. Star Petroleum Refining is expected to see strong GRMs in 4Q21 and FY22, in tandem with stronger demand from the transportation industry, the winter season in the northern hemisphere, and reopening of the global economy. We believe the company's earnings bottomed out in 3Q21, following the impact of COVID-19.
