Seeking An Improved 2022 Outlook  
Sector Update

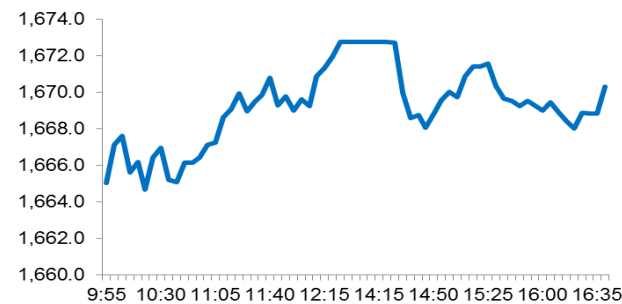
Keep NEUTRAL, Top Pick: Home Product Center (HMPRO). A rebound in local consumption and consumer confidence for out-of-home activities, along with a handful of government stimulus measures may improve the retailing outlook from 1H22F. Sector earnings should see strong growth from a low base, with full-year store operations and continued expansion plans. The return of international visitors may start improving outlet performance in tourism destinations from 2H22F. We prefer discretionary retailers from intact earnings growth, and as key beneficiaries to spending boost schemes in 1Q22.
