Growth Period To Kick In; Reiterate BUY

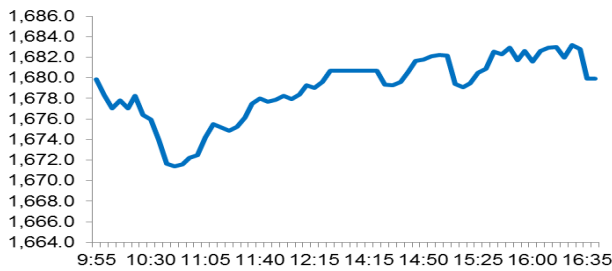
Company Update

Reiterate BUY and a SOP-based TP of THB10.10, 14% upside with >1% FY22F yield. After a glum FY21, we expect Bangkok Expressway and Metro's numbers to improve strongly in FY22, as expressway traffic and Blue Line Mass Rapid Transit ridership should ramp up immediately after the current wave of Omicron infections begin to subside. 2Q22 should be a period when its metrics show a solid improvement, and we expect net profit growth to be stellar this year.
