 Company Update

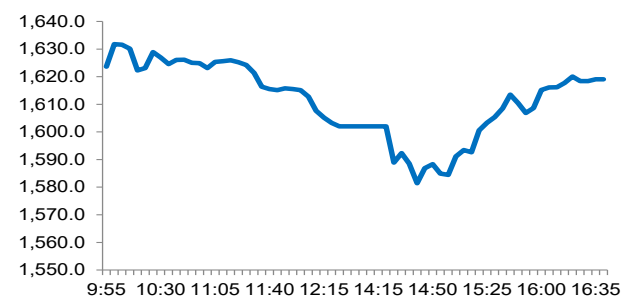
