Immunity-Boosting Demand Continues; Keep BUY
 Company Update

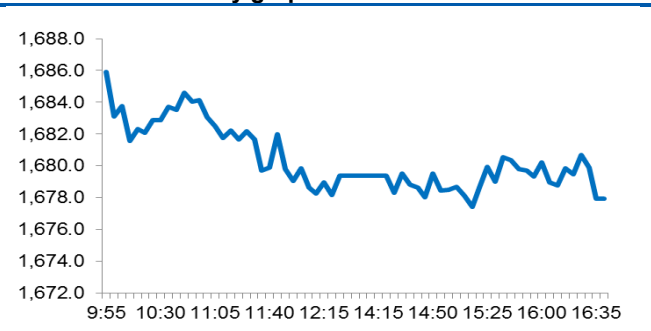
Keep BUY, new FY22F DCF-based THB50.00 TP from THB49.00, 12% upside and c.2% yield. We conservatively expect Mega Lifesciences to deliver a slight 5% core profit decline in 2022 from a high earnings base in 2021, as well as a wider revenue mix from its low GPM products distribution business. Still, its resilient earnings growth may continue over 2023-2024, along with rising health and wellness trends.
