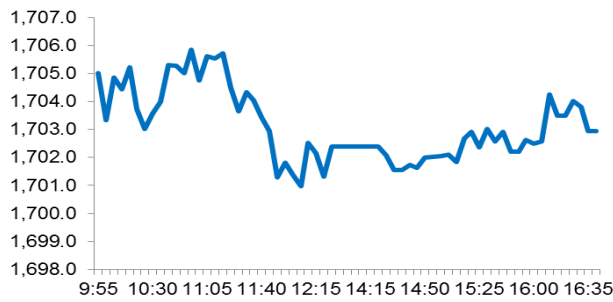

Property	<p>A consumer confidence survey showed a large uptick in Mar 2022 from Dec 2021, with one of the possible outcomes an increase in housing demand going forward, according to property research and consultancy Terra Media and Consulting Ltd. Its managing director said the overall index of 200 respondents in March rose to 85.4 from 75.6 in Dec 2021. The majority in seven career groups were confident about the future, particularly their financial status for the next 12 months, which they expect to be better.</p> <p>Terra surveyed the confidence of seven career groups comprising business owners with no employees, business owners with 10 employees or fewer, professionals such as teachers and doctors, department managers or managers in private firms, general employees in private firms, freelancers, and civil servants. Expectations regarding financial status over the next 12 months had the highest total index at 94.4.</p> <p>The survey also asked whether this was a good time to purchase high-value items such as property or cars. The total index for this question was the lowest of the five questions at 78.5. Freelancers had the highest index at 100, while professionals showed the lowest confidence at 33.3. Large developers said that the market in the first three months showed good signs despite flat growth in bookings because the majority of homebuyers used cash. Small developers had no bookings despite a number of customer visits. (<i>Bangkok Post</i>)</p>	<p>The key takeaways from the survey: i) Locals in diversified careers including the self-employed and employees are more confident about future economic prospects, ii) there is low-to-moderate demand for new big-ticket items especially property, and iii) presales of new residential units have been concentrated among large developers.</p> <p>The survey's findings are in line with our expectations for the performance of property developers on YTD basis. Based on our checks with listed developers, small-to-medium sized developers have been struggling to boost their presales – although their housing unit inventory may be cheaper than new units under construction, due to the recent surge in construction costs caused by higher energy prices. Listed companies' – especially major brands – presales have not been evenly boosted by better confidence levels. Only a few developers such as Supalai (SPALI TB, BUY, TP: THB24.90) and AP Thailand (AP TB, BUY, TP: THB11.35) were able to boost their presales level with >20% YoY growth on a YTD basis, while other large developers commanded a slight growth in presales during the same period. Land and Houses (LH TB, BUY, TP: THB9.45) could generate stronger presales in Jan 2022 and this softened in Feb 2022 due to the rising number of COVID-19 cases. For LPN Development (LPN TB, SELL, TP: THB3.10), its presales have only increased slightly with <10% YoY growth, although the company has adopted the pricing strategy for the completed condominium unit inventory.</p> <p>In our view, low-rise housing developers still dominate the overall industry for this year, although it is expected that the condominium market will improve from FY21's low-ebb level. Also, our Top Picks including SPALI and AP have performed well so far, in terms of boosting their presales on YTD basis, and both companies can be regarded as the most aggressive in terms of their planned new project launches this year. We keep the call and TP for all the stocks mentioned.</p>	NEUTRAL
