Long-Term Opportunities, Near-Term Costs; BUY

Company Update

Keep BUY, new THB34.00 TP from THB35.00, 42% upside and c.3% FY22F yield. Charoen Pokphand Foods is now benefiting from high swine and chicken prices in Thailand and Vietnam. It also began exporting chicken products to Saudi Arabia for the first time since 2004. While raw material costs are a major concern, we believe CPF is in a strong position to capture the recovery in post-pandemic consumer spending as well as opportunities to open new export destinations thanks to its diversified business model and established brands.

Weak Presales In 1Q22 As Expected; Keep SELL

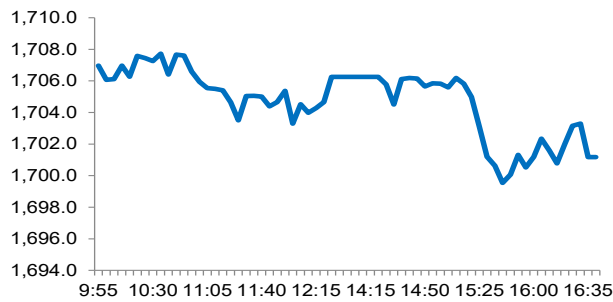
Company Update

Maintain SELL and TP of THB3.10, 34% downside. We believe LPN Development's announcement of unexciting 1Q22 presales proved to be its weakness compared to other leading developers that showed strong presales growth during the same period. As such, this stock will remain unappealing in the near term, in our view.
